TERMS AND CONDITIONS OF SWISSGARDE DISTRIBUTOR AGREEMENT

Swissgarde (Pty) Ltd, hereinafter referred to as ("the Company") and the Applicant hereinafter referred to as ("the Distributor") hereby agree that :

- The Distributal is a principal of bis/her independent business and is not an employee or agent of the Company and operates his/her business as an independent distributor who buys and distributes the Company's products.
- buys and destroyes the company's products.

 The Distributor shall self the products in accordance with the policies, procedures and regulations set out in the manual which forms part of the kit which the Distributor shall be obliged to prentate on acceptance by the Company of this application ("the Business Manual"). The folicies, procedures and regulations set out in the Business Manual of this Agreement and may be of tanged or amended by the Company from time to time, in the event of any of the provisions of this document being in conflict with the Business Manual, then the provisions of this document shall prevail.
- The Distributor shall be responsible of the training and motivation of the distributors which harshe introduces and which such distributors introduce to the business of the Company ("the Business Opportunity").

 The Distributer shall be entitled to a discount from the Company or Franchisee of the Company on the Product (Product Discount') which harshe purchases from the Company or Franchise of the Company in accordance with the Product Discount Schedule as set out in the Marketing Plan of the Business Mercuet, which may be amended from time to time by the Company.
- The Company or Franchisee of the Company shall issue credit notes to the Distributor in respect of the Product Discounts that are due to the Distributor, in accordance with the Marketing Plan
- Mandating Ham.

 The Distribution hereby inevocably cedes from time to time his/her right, title and interest in and to portions to his/her claim against the Company arising out of such credit noise to the persons identified as the destionance hieroric ("the Cessionaries") in accordance with the Recommended Service Fee Schedule as set out in the Marketing Plan of the Business Manual. The Distribution hereby acknowledges that he/she has read and understood the Recommended Service Fee Schedule of attended Marketing in the business Manual. It is reconded that the dessions are provided to the Cessionaries as consideration for services perioder by the Cessionaries to the Distributor, such services including those of assisting the Distributor in setting the products and enotivating and training the Distributor.
- The Cessionsales hereby accept the said cessions.

- The Company levely acknowledges and consents to the said pessions in the full knowledge that the cessions will have the effect of splitting the claims against the Company in terms of credit notes, and may have the effect of rendering the Company's liabilities under the credit notes more onerous. The Company agrees to pay the Cessionaries the amounts owing by the Distriction to the Cessionaries calculated in accordance with the Recommended Services Fee Schedule as set out in the Markot Plan of the Business Manual.
- The Distribution levelsy appoints the Company as its agents to accept, on his/her behalf, cession of any claims against the Company which are ceded to the Distributor in respect of service fees calculated in accordance with the Recommended Services Fee Schedule, by any distributor who the Distributor introduces to the Business Opportunity or who such distributor introduces to the Business Opportunity.
- Once the Distributor qualifies for Executive Status in terms of the Business Manual he/she may only participate in the Royalty Programme if he/she sets the Products exclusively and does not operate on behalf of any other mutti-level marketing, network marketing, direct setting company or any pyramid schemes.
- The Distributor may not recruit any Swissgarde distributors for any other multi-level marketing, network marketing, pyramid schemes or direct selling companies for the duration of this Agreement. Shellid the Distributor fail to comply with this clause, the Company may cancel the Distributor's distributorably in terms of this Agreement and withhold any Volume Discount and/or royally payments from the Distributor.
- The Distributor may only move from one sponsor to another with the approval of the Company, which reserves the right to exercise its sole discretion in granting or denying such approval.
- The Company may amend or change the recommended prices and range of the Products, the Sales and Marketing Policies, Volume Discounts and Royalty Programs, as set out in the Business Manual, on 30 day's within notice by the Company to the Distributor.

- This Agreement shall continue indefinitely subject to either party being entitled to cancel
 this Agreement by giving the other party 30 days written notice of his/her interiors to do so.
- 17. If the Distributor terminates this Agreement withing 14 days of signature hereto, and returns all the Company's documentation. Products and promotional material to the Company, then the Company will reimburse the Distributor with the cost of the stock purchased by the Distributor withich is returned to the Company in a condition which the Company, in its sole discretion, determines to be resaleable.
- The Products may not be sold or displayed by the distributor in any retail store or outlet serving the general public nor may the Products be sold to any retail store or outlet for resale to the general public. This includes the sale of the Products at the fiea markets by any other informal retail method e.g. on the street.
- The Distributor shall store the Products in accordance with the directions given to it by the Company from time to time.
- The Distributor shall be responsible for any loss or damage to any Products that are in the Distributor's possession and control.
- 21. The Distributor shall not make any claims, statements, representations or give any warranties about the Company or the Products, other than as contained in the Business Manual and any other literature which the Company may distribute from time to time.
- The Distributor shell represent the Company and the Products in an honest, accurate and legal manner and shall not make any false claims in respect of the Products or the Business Opportunity.
- 23. The Company makes no medical claim or representations regarding the Products.
- The Distributor shall sell the Products in the form that they are packaged and may not repack the Products or change the labels on the products.
- The Distributor may only advertise the Products within the parameters laid down by the Company from time to time and may only distribute written information regarding the Products or the Company that is supplied to him/her by the Company.
- The Distributor shall participate in the Company's regular mailings and hereby grants the Company the right to set off the annual mailing fee charges incurred by the Company against the Distributor's Products Discounts, on the anniversary of signature of this Agreement, provided that the Company has fulfilled its obligations in terms of the cessions referred to in clause 9 above.
- On termination of this Agreement, for whatever reason, the Distributor shall return all the Products, the Company's promotional material and documentation which are in the Distributor's possession or control to the Company and the Company shall repay to the Distributor the price paid by the Distributor for the Products which are returned to the Company; in it is said discretion, determines to be resalieable. The Company shall be entitled to deduct any amounts which the Distributor owes to the Company from the amount returned by the Company to the Distributor owes to the Company from the amount returned by the Company to the Distributor.

In the event that any provisions of this Agreement are held to be invalid or unenforceable, such invalidity or unenforceability shall not affect the validity or enforceability of this Agreement as a whole, which shall in such case be construed as though the invalid and unenforceable provisions had been omitted.
- The Distributor shall not be entitled to cede or assign any of his/her rights or obligations under this Agreement without the written consent of the Company.
- The parties' chosen addressees ("domicilla") for the purpose of this agreement are as set out in the Distributor Application Form annexed hereto.
- The Agreement constitutes the sole record of the Agreement between the parties with regard to the subject matter hereof. No party shall be bound by any express or implied term, representation, warranty, promise or the like not recorded herein.
